**Section 1 Introduction**

- 1.1. South Asian Federation of Accountants (SAFA), an Apex Body of SAARC was set up in 1984 for promoting the accounting profession in the countries in South Asia and internationally with a mission to bring the accounting bodies in the region together at a common forum and facilitate professional cooperation in the areas of education, training, technical and ethical standards. The SAFA comprises of the Chartered Accountancy and Cost and Management Accountancy Bodies in India, Pakistan, Nepal, Bangladesh and Sri Lanka. Bhutan, Maldives and Afghanistan SAARC member countries representatives attend meetings as observers. China, Korea and Japan being observers of SAARC are invited and also given observer status.
- 1.2. This report outlines the activities of SAFA from 1<sup>st</sup> November 2007 to 10<sup>th</sup> October 2008 and future planned activities. During the period under report following events/meetings were held:

**Election of new Office Bearers of SAFA for 2008 and Resignation of Dr. Ashok Haldia as Permanent Secretary**

- 1.3. SAFA Assembly, at its 66th meeting held on 31st December 2007 through teleconferencing has elected/appointed its office bearers for the year 2008 as under:

- 1.4. Dr. Ashok Haldia, Permanent Secretary SAFA has resigned from the office w.e.f. 12<sup>th</sup> August 2008 and in his place, till the appointment of new Permanent Secretary of SAFA, Mr Asif Iqbal has been appointed as the Acting Secretary of SAFA.

**SAFA Silver Jubilee Celebrations**

- 1.5. On 22<sup>nd</sup> August 2008, SAFA has entered into its silver jubilee year and to commemorate the silver jubilee celebrations, SAFA and its member bodies are organizing events throughout the year. The inaugural event was held on 22<sup>nd</sup> August 2008 at Colombo that would be followed by a series of events to be organized by SAFA member bodies.

**Section 2 Activities in Support of IFAC's Mission**

**Supporting IFAC's Role as the International Standard Setter in the areas of Auditing, Education, Ethics and Governmental Financial Reporting**

- 2.1. A comparative study on Quality Control Framework prevailing in SAFA member bodies has been prepared by SAFA Committee on Quality Control. Based on comparative study first draft of Model Quality Control Framework for SAFA member bodies has also been prepared. The draft of which would be considered and would be tabled before the Board by 21<sup>st</sup> November 2008.
- 2.2. A survey on code of conduct of professional accountants in business in SAFA Region has been conducted by SAFA Committee on Professional Accountants in Business based on

code of conduct of PAIB of IFAC. The survey was based on 10 listed companies of four different industries, across five different Countries of SAFA Region with the help of member bodies. The survey has been extended and the final report would be presented before the Board in its next meeting scheduled to be held on 21<sup>st</sup> November 2008.

- 2.3. SAFA has sent a proposal to SAARC Secretariat for assisting it in introducing course curriculum in commerce and related areas at the graduate, postgraduate and doctorate level of SAARC University.

**Actively support the adoption of, and assist in the implementation of, international standards**

- 2.4. A model minimum common curriculum for chartered accountancy bodies in SAFA Region has been finalized based on IFAC Standards. Similar exercise, undertaken for cost and management accountancy bodies is in finalization stages.

**Continually enhance the relevance of the profession**

- 2.5. SAFA directly and through its member bodies have been in touch with Afghanistan, Maldives and Bhutan for the institutionalization of accountancy profession. The efforts of SAFA have lead to establishment of Certified Practicing Accountants (CPA) in Maldives
- 2.6. Two new committees have been set up namely:
- Task Force for Harmonization of Fiscal and Tariff Regimes
  - Small and Medium Practices (SMPs) Committee
- 2.1. A new award for Corporate Governance has been awarded for the first time with the help of an independent corporate governance-rating agency to promote and improve the awareness and implementation of Corporate Governance in South Asian Region. The evaluation of Best Presented Accounts Award Competition 2007 has also been finalised and BPA Awards Ceremony is scheduled to be held on 15<sup>th</sup> November 2008 at Hyderabad, India.
- 2.7. SAFA is also planning to introduce a new award for Corporate Social Responsibility.

**Be an influential voice for the global accountancy profession**

- 2.8. SAFA has been mobilizing its member bodies to send comments on various Exposure Drafts issued by IFAC and its committees. Apart from that consolidated comments on issue specific, which are of the interest of SAFA Region as a whole has also been sent.
- 2.9. Mr. Indrajith Fernando the then President of SAFA had attended IFAC Regional Organization and Grouping meeting held November 2008 at Mexico in the month of November and gave valuable inputs.
- 2.10. Mr Kamlesh Vikamsey, a representative of SAFA Region has been elected as the President of CAPA. Apart from him four other members from SAFA Region are on CAPA Board.
