### **MG Co-Chair Bios**

### Sagar Teotia

Mr. Teotia was appointed MG co-Chair as of July 2019. He was named the U.S. Securities and Exchange Commission's Chief Accountant in July 2019. He previously served as Acting Chief Accountant since June 2019.

Prior to joining the SEC, Mr. Teotia was a partner at Deloitte in the national office, where he frequently consulted on accounting issues in a number of areas, including financial instruments, business combinations, and compensation matters. Earlier, Mr. Teotia served as a professional accounting fellow in the Office of the Chief Accountant where his responsibilities included providing conclusions on complex accounting issues and actively monitoring current standard setting projects.

#### Ana Martínez-Pina

Ms. Martínez-Pina was appointed MG co-Chair as of July 2019. She is the Vice Chair of the Spanish Comisión Nacional del Mercado de Valores (CNMV), the Spanish securities regulator.

Ms. Martínez-Pina joined the CNMV in 2016 as the Vice-Chair, after chairing the Spanish Accounting and Auditing Institute (ICAC), the accounting standard setter as well as the auditor oversight authority in Spain. She also chairs ESMA's Corporate Reporting Standing Committee. Among other senior regulatory roles in Spain, Ms. Martínez-Pina chairs ESMA's Sustainable Coordination Network.
